Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain weak. Non-fiber pricing (scrap + CRV) has not changed much. Scrap pricing for recovered fiber remains very weak. Cardboard (OCC) and Mixed Paper pricing and movement remain dependent on the export market.

Fiber (OCC and Mixed Paper) pricing is heavily influenced by demand in China. That demand is regulated by government issued import permits. Those permits are carefully controlled, and beginning in 2018 the quantity (tons) released continues to be reduced. Those reductions, which became much more dramatic in 2019, have a serious impact on global pricing, which remains very weak.

As China has reduced their demand for imported Fiber those tons continue to be exported to other SE Asian countries. However, the supply demand imbalance in SE Asia continues to depress pricing. The small domestic demand in western US for Fiber remains static, but most of the Fiber recovered at MRFs in CA all flows to SE Asia. With China reducing their demand for Fiber in Q4 2019, it is unlikely there will be price increases for recovered fiber in 2019. The best we can hope for is that China continues to import recovered paper/cardboard in 2020, and that in Q1 2020 there is some upward movement on pricing.

The supply demand imbalance for recovered paper/cardboard allows consuming mills to be more selective about who they purchase materials from and what quality they are willing to accept. Throughout 2019 the quality requirements for export paper mills has become stricter, and MRFs that cannot meet them are without orders. When that happens then material is sent to the landfill. SBR continues to have extra staff in the MRF to reduce contamination while we run the system at a slower speed thereby generating reasonable quality recovered paper/cardboard which export paper mills are willing to purchase. Unfortunately, when the cost to transport such material from Shoreway to the port exceeds the value of it loaded into containers at the Port of Oakland Container Yard, then the value of the material FOB Shoreway (origin) is negative.

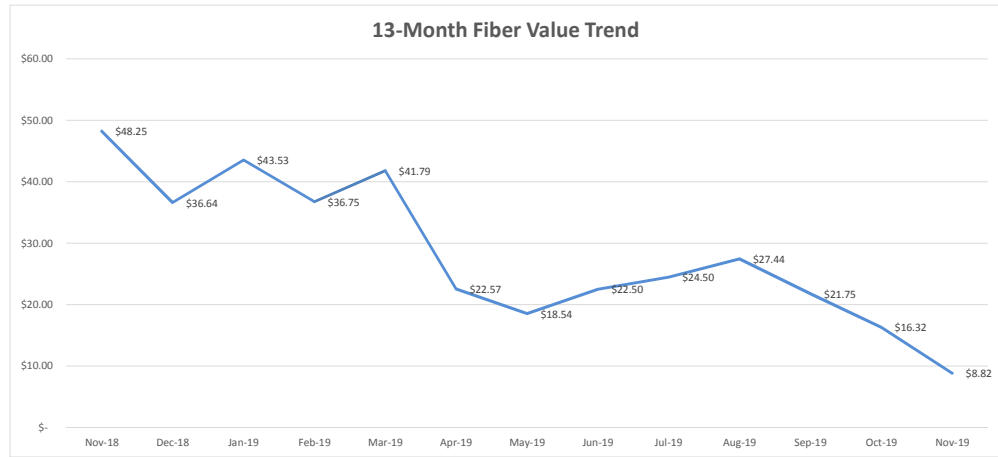
