**Commodity Market Update**

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain weak.

Non-fiber pricing (scrap + CRV) has not changed much, but oversupply of virgin resin is causing some plastic scrap pricing to weaken. Markets for #1PET and #2 HDPE remain active, but there are no viable domestic or export markets for post-consumer MRF sorted plastics #3-#7.

Scrap pricing for fiber remains depressed. Cardboard (OCC) and Mixed Paper pricing and movement remain completely dependent on the export market.

OCC pricing appears to have bottomed out. There are signs the OCC pricing may not deteriorate further this year, and since China released some import permits for 2020 (at much lower levels than 2019) there is a slight uptick in demand in SE Asia.

Mix Paper pricing remains depressed. Markets in SE Asia are in oversupply and fewer countries are importing Mixed Paper. Recently Indonesia has begun to clarify their import and inspection procedures, but movement to that country is almost non-existent. India has begun to impose import restrictions on Mix Paper, and although most of those tons are shipped from US East coast there is pressure impacting USA West Coast supply which make export orders few and far between.

The outlook for Mix Paper is bleak. SBR continues to sort and market Mix Paper, but pricing is slightly negative FOB the Shoreway facility. Several MRFs have either stopped sorting Mix Paper or have invested money to upgrade their Mix Paper to High Grade Paper. The most common method to generate High Grade Paper is to deploy advanced sorting equipment to remove brown fiber (which becomes OCC) and contamination.

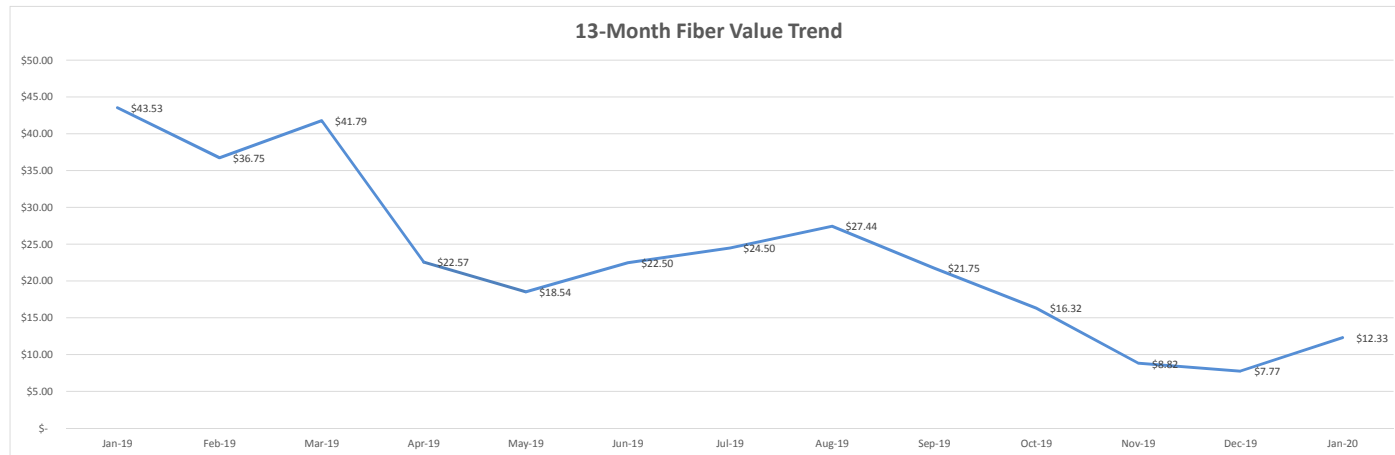
