**Commodity Market Update**

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain weak. Non-fiber pricing (scrap + CRV) has not changed much, but mixed rigid plastic no longer has a market. Scrap pricing for Mix Paper remains depressed, with no signs of recovery. Cardboard (OCC) pricing has rebounded with strong demand, but pricing is still well below historical levels. There are some concerns that this recent surge in demand for OCC may be short lived. Mix Paper and OCC movement remains 100% dependent on the export market, just as it has for decades.

Due to the National Sword change in laws, which were implemented throughout 2018, the export market remains weak. Throughout 2018 China banned some material, imposed unrealistic quality requirements, and reduced their demand for imported fiber. Those changes in law continues to impact SBR's operations. The operational changes impacting SBR throughout 2019 continue in 2020. The impact is higher costs to SBR which are the direct result of the National Sword change in laws.

The domestic demand in western US for Fiber remains static, which from a practical perspective basically means that there is none. As a result almost ALL of the Fiber recovered at MRFs in CA flows to SE Asia. Over the next few years demand for recovered fiber will increase worldwide, and many are hopeful that this will result in higher prices for recovered fiber, which will still be going to export markets.

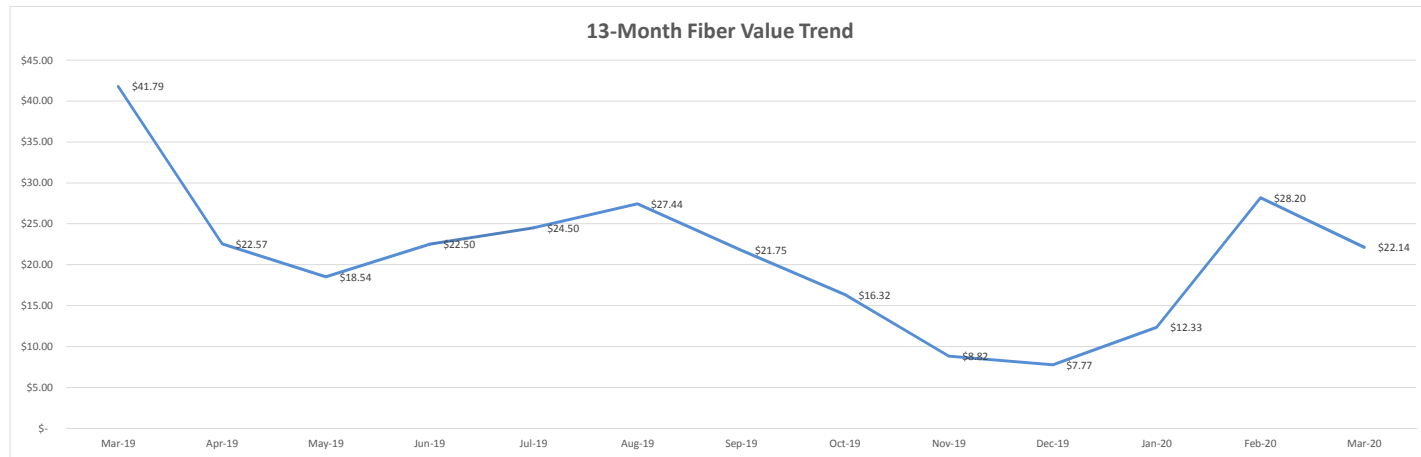
