Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) are stable. Non-fiber pricing (scrap + CRV) has not changed much, but mixed rigid plastic no longer has a market.

Scrap pricing for Mix Paper remains depressed, with no signs of recovery. Cardboard (OCC) pricing continues to strengthen, but the recent uptick is now being driven by supply shortage due to limited economic activity due to the pandemic.

Due to the National Sword change in laws, which were implemented throughout 2018 and decimated the recycling industry in 2019, the export market remains weak. Throughout 2018 China banned some material, imposed unrealistic quality requirements, and reduced their demand for imported fiber. Those changes in law continues to impact all MRF's in the US, particularly CA. As 2020 unfolds SBR's MRF operations continue to suffer economic hardship due the change in law.

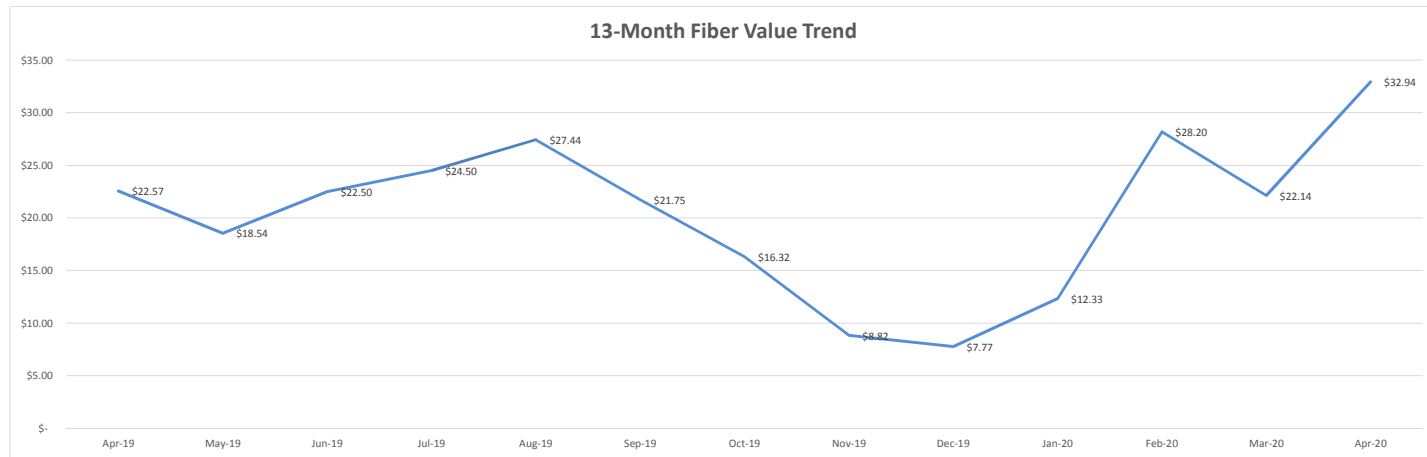
