Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain weak.

Scrap pricing for Mix Paper (MP) has bumped off the bottom. In 2017 pricing was in the \$100 range, but since the change in law National Sword impact the market price has essentially been zero.

Scrap pricing for Cardboard (OCC) has dropped again. In 2017 pricing was in the \$200 range, but since the change in law National Sword impact the market price has been essentially half the levels of what they had been.

Due to China's National Sword change in laws, which began their implementation in 2018 and decimated the recycling industry in 2019, the export market remains weak. Those National Sword changes in law continue to be implemented, which includes China's stated intention to ban the import of recovered fiber in 2021.

The domestic demand for paper and cardboard has not emerged, nor is it expected to. The only viable demand remains in SE Asia, which is slowly adding capacity to replace China's withdrawing from the market.

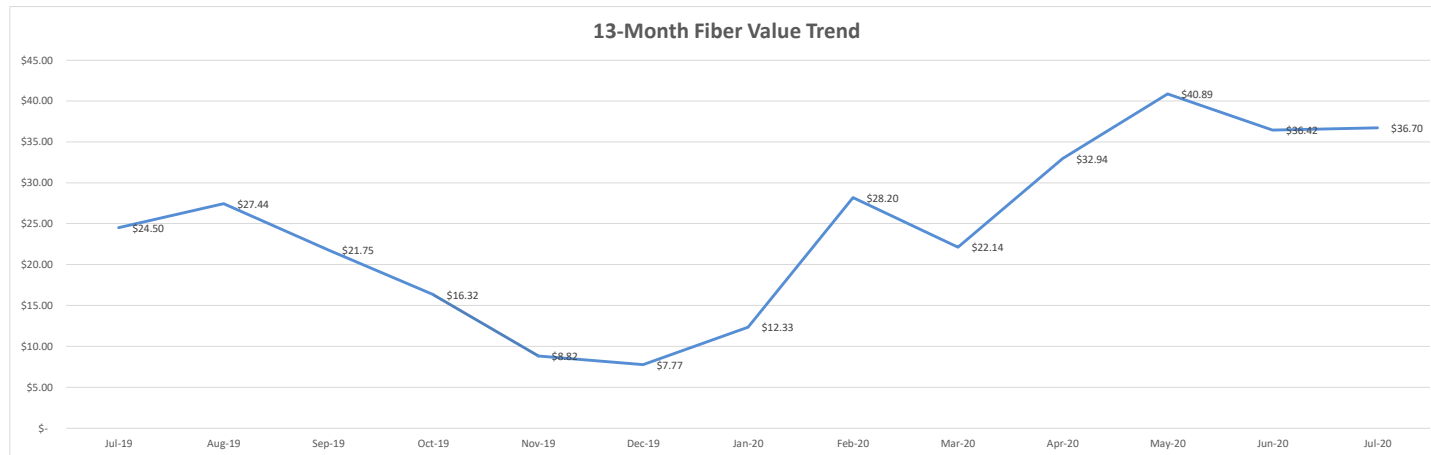
