Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) are improving slightly. California Refund Value (CRV) program remains healthy, but there is pending legislation (SB 38) to replace the Beverage Container Recycling Program with a Redemption program which would impose a stewardship fee and make other significant changes that could negatively impact the Authority.

Scrap pricing for Mix Paper (MP) and Cardboard (OCC) continues to be negatively impacted by severe disruptions to vessel and export container equipment flows throughout CA. Although the demand in SE Asia for both MP and OCC remains healthy, the transportation and logistics costs continue to increase.

The onsite baled inventory situation remains dynamic and fluid, but at this time there is no need to find alternatives to exporting from the port of Oakland.

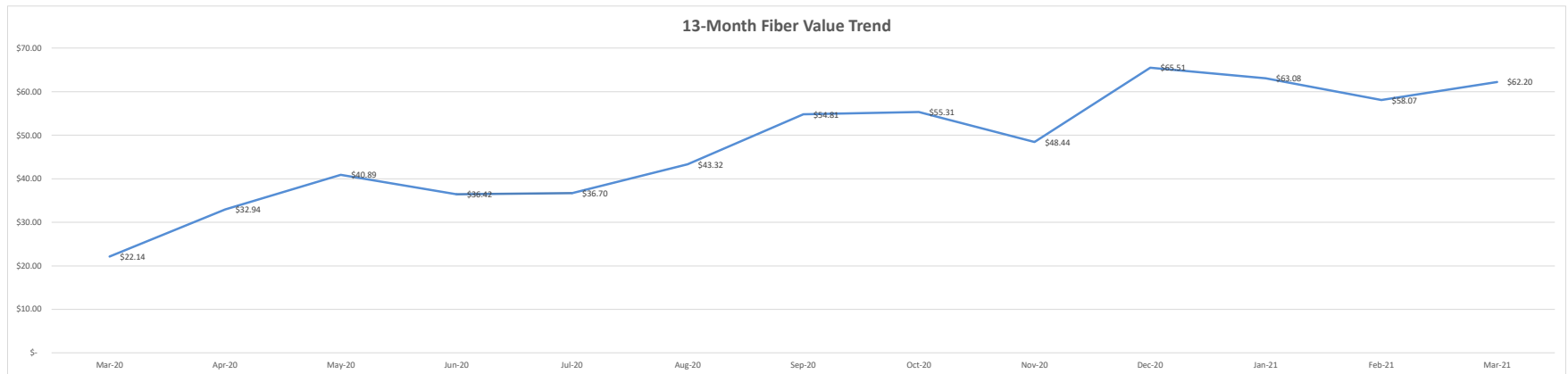
