**Commodity Market Update**

Scrap values for non-fiber (plastic, glass, aluminum, and metals) continue to improve slightly. California Refund Value (CRV) program remains healthy, and pending policy changes are not expected to negatively impact the refund, processing, and administrative payments which are the critical and stable component of the recycling revenue.

Scrap pricing for Mix Paper (MP) and Cardboard (OCC) have increased due to robust demand in SE Asia where many mills have increased their wastepaper consumption. Although the demand in SE Asia for both MP and OCC remains healthy, the transportation and logistics costs continue to increase due to disruptions in steamship lines schedules and space availability.

The onsite baled inventory situation remains dynamic and fluid, and temporary stacking of bales in the parking lot on site has resumed. So far transporting bales to Southern California for trans-loading has not been required.

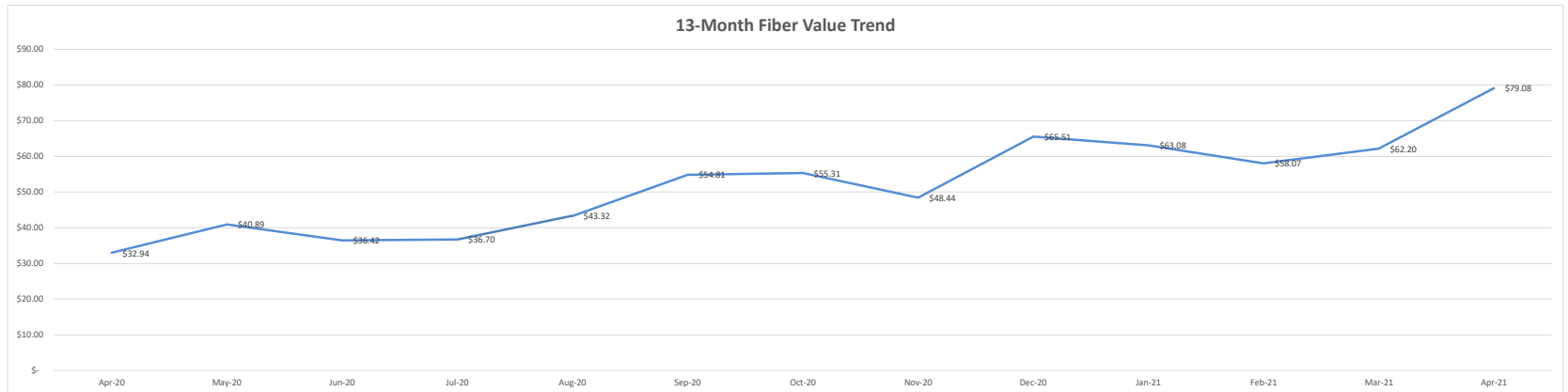
