Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) continue to improve slightly. The California Refund Value (CRV) program remains healthy, and the proposed legislation (SB38) which could reduce payments for MRF materials has been delayed.

Scrap pricing for Mix Paper (MP) and Cardboard (OCC) remains strong. The material continues to go exclusively to SE Asia via export containers from the port of Oakland. Transportation and logistics disruptions to steamship lines schedules continues to impact product movement.

The onsite baled inventory situation is currently under control, and temporary stacking of bales in the parking lot on site has temporarily been suspended.

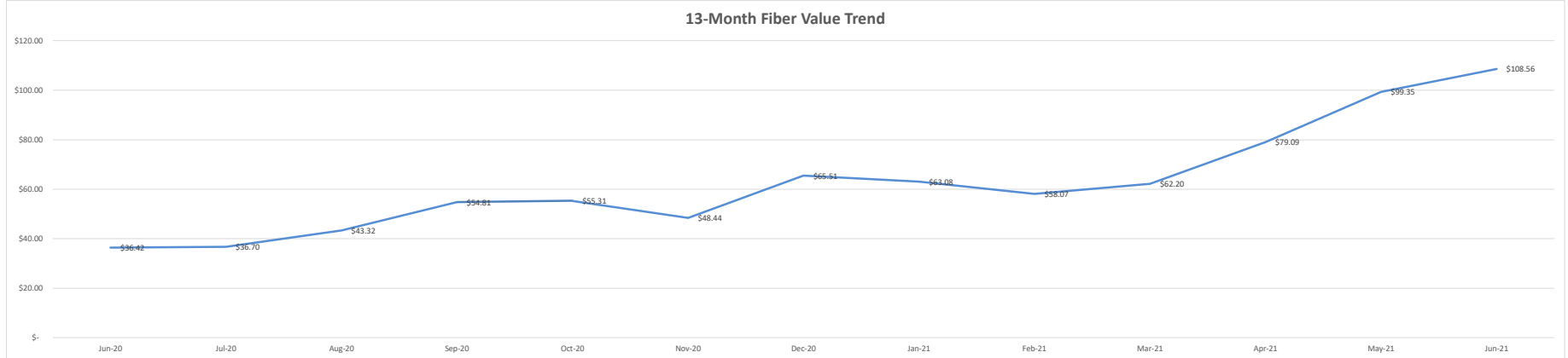
