Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain stable.

Scrap pricing for Mix Paper (MP) and Cardboard (OCC) continues to increase. A combination of healthy domestic and export demand is driving pricing up.

The MP and OCC fiber continues to ship to end users in SE Asia via export containers from the port of Oakland. Transportation and logistics disruptions to steamship lines schedules continues to impact product movement on the entire west coast.

The onsite baled inventory situation is currently under control, but due to vessel schedules and port issues we have resumed temporary stacking of MP and OCC in the portion of the parking lot which is assigned and permitted for such use.

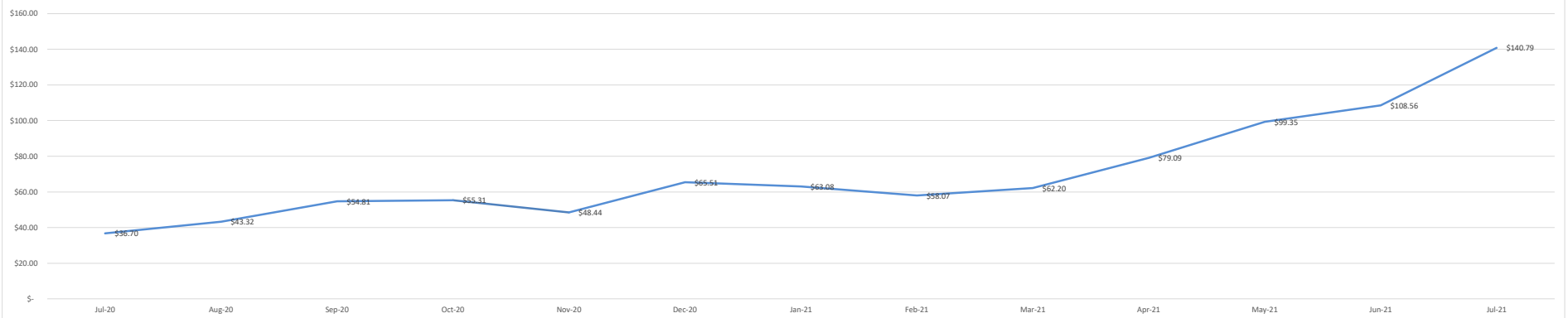
