Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain stable.

In September, scrap pricing for Mix Paper (MP) and Cardboard (OCC) dropped in value by \$17.00 and \$10.00 per ton respectfully . However, over the past year average recovered fiber pricing has doubled and is currently back to levels last seen in 2018. There is some concern in the marketplace that COVID outbreaks in SE Asia may cause a decrease in demand, which could cause a downward price correction.

The MP and OCC recovered fiber continues to ship to end users in SE Asia via export containers from the port of Oakland. Nevertheless, the combination of reduced schedules and port issues requires that SBR continue with some temporary stacking of MP and OCC in the portion of the parking lot which is assigned and permitted for such use.

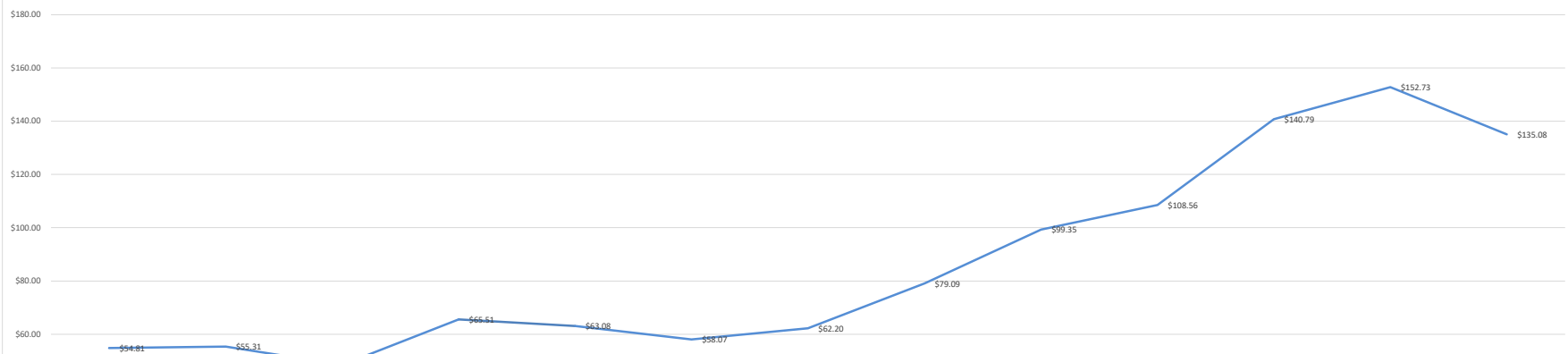
