Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain stable. CalRecycle changed the CRV rates in January 2022 with minor change to Refund Value and a decrease in Processing Payments for plastics. Scrap pricing for Mix Paper (MP) and Cardboard (OCC) are still impacted by port issues which hurt all MRFs in CA. The combination of reduced vessel schedules and port issues requires that SBR continue with some temporary stacking of MP and OCC in the portion of the parking lot on site which is assigned and permitted for such use.

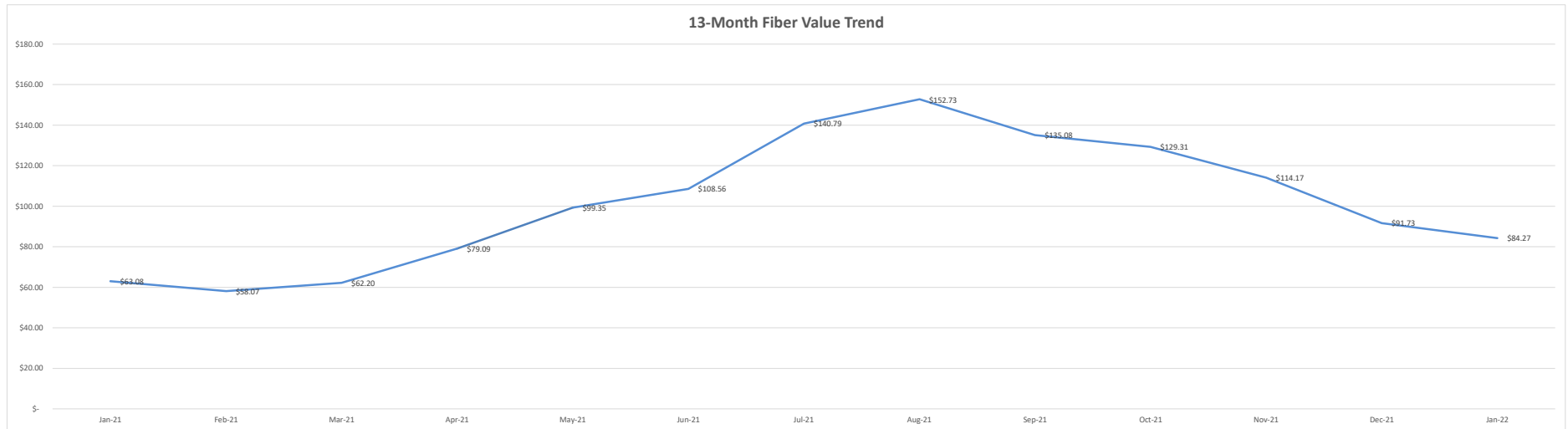
