Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) continue to fluctuate within their normal range.

Scrap pricing for Mix Paper (MP) and Cardboard (OCC) remain negatively impacted by port issues which hurt all MRFs in CA. Ongoing issues include: fewer steamship lines taking export cargo; high fuel prices; and erratic schedules.

Although SBR has been able to empty the parking lot of the temporarily stored OCC and MP bales, that outside space needs to be kept available because it could be needed at any time.

The Mixed Paper (MP) produced at SBR has fewer markets in SE Asia because some countries do not allow it, others impose higher quality requirements, and some have inspection requirements which are onerous. As a result there are only a few countries willing to accept the Shoreway baled MP fiber. In order to ensure ongoing markets for MP it will be important for the MRF equipment to be upgraded with industry proven technology to reduce contamination.

Negotiations with the International Longshoremen Warehouse Union (ILWU) have begun with the Pacific Maritime Association (PMA). It is too early to tell if there will be service disruptions at the west coast ports due to labor issues, but some in the industry are expressing hope that ILWU-PMA contracts can be negotiated without disrupting daily operations.

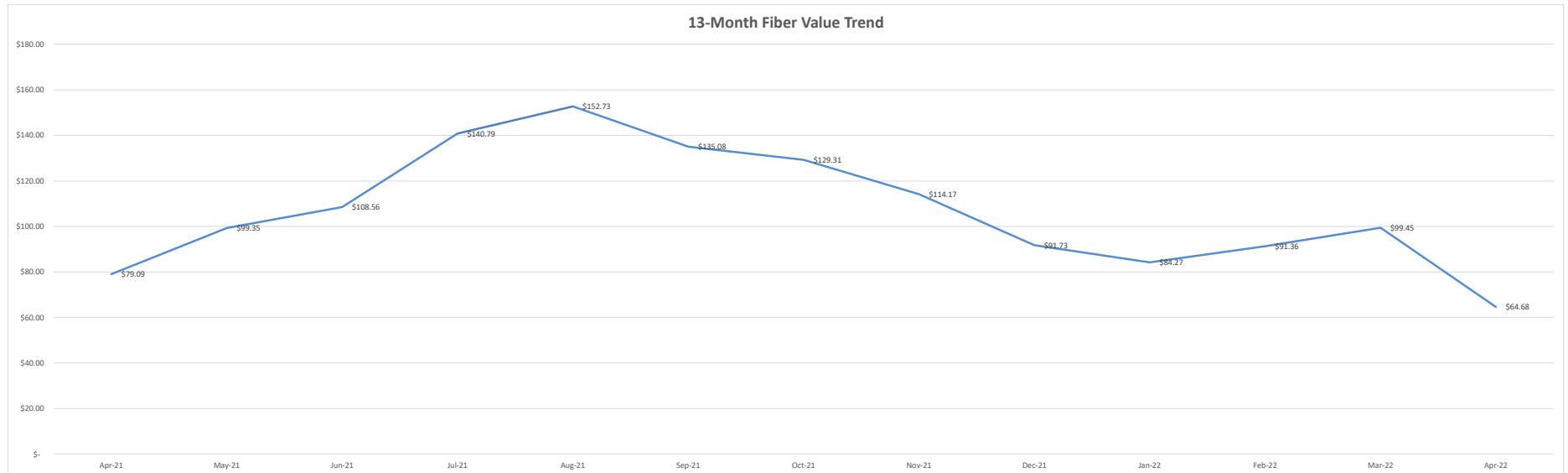
