Commodity Market Update

Higher interest rates combined with inflation is causing a slowing of US consumption, and this is reducing demand for raw materials used to produce packaging materials. This is having a negative impact for global demand of many recyclables, which causes pricing to deteriorate in domestic and export markets

Scrap values for non-fiber (plastic, glass, aluminum, and metals) are weakening. The only stable non-fiber commodity is glass.

Scrap values for recovered fiber (OCC cardboard and MP mix paper) has peaked. Reduced demand in North America has increased the supply available to the export market, which will cause price erosion. At this time it is difficult to predict how long recovered pricing will remain weak, or how low recovered fiber pricing will go.

The Mixed Paper (MP) and OCC produced at SBR continue to move export to Asia directly to end user paper mills. Recent truck driver disruptions at the port of Oakland have impeded regular product movement in and out of the port, and has essentially shut the port down on multiple occasions. As such bales of recyclables are again being stacked in the permitted outside storage area at Shoreway.

Negotiations with the International Longshoremen Warehouse Union (ILWU) and the Pacific Maritime Association (PMA) should resume soon. There is hope that service disruptions at west coast ports can be avoided.

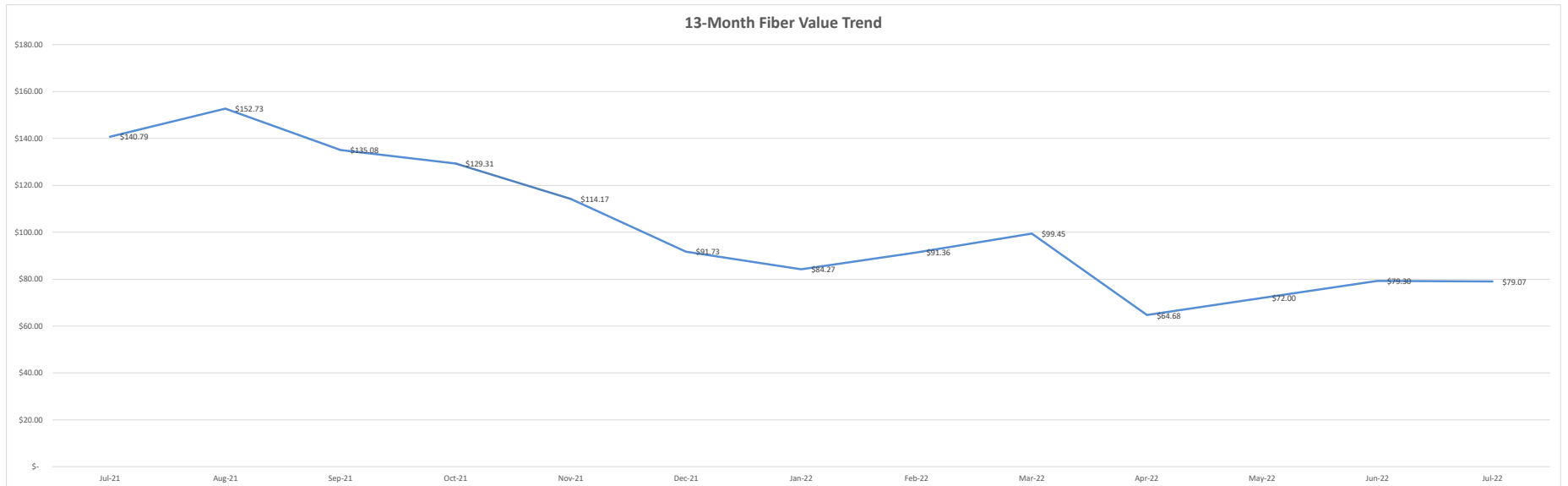
