Commodity Market Update

Scrap values for recovered fiber (OCC cardboard and MP mix paper) have stabilized at a low level.

Scrap values for plastic, aluminum, and metals remain weak.

Complications continue at the port of Oakland, and the ILWU-PMA labor negotiations have still not been resolved. If there is a service disruption at the port of Oakland then commodity pricing for recovered fiber could fall.

Export vessel frequency at Oakland is sufficient to continue with regular shipments, and no bales are being stored outside. Rainfall is well above normal levels creating manageable issues with excess moisture.

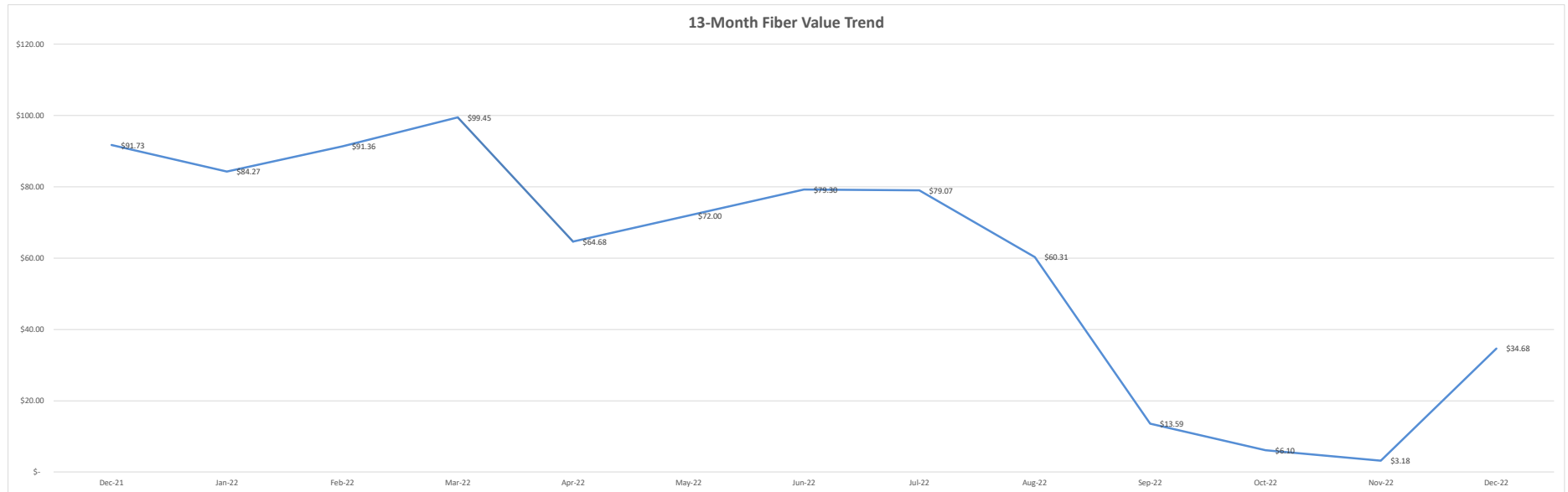
