Commodity Market Update

Scrap values for recovered fiber (OCC cardboard and MP mix paper) are stable, with a minor improvement to MP pricing. The heavy rainfall over the past few months has reduced the amount of dry recovered fiber available on the US west coast, and as a result pricing for OCC and MP may rebound slightly next month.

Scrap values for plastic, aluminum, glass, and metals remain stable.

Complications continue at the port of Oakland. The ILWU-PMA labor negotiations have still not been resolved, and a quick resolution is unlikely. Nevertheless the port continues to operate each day with inbound and outbound cargo flowing.

Export vessel frequency at Oakland is sufficient to continue with regular shipments, and no bales are being stored outside.

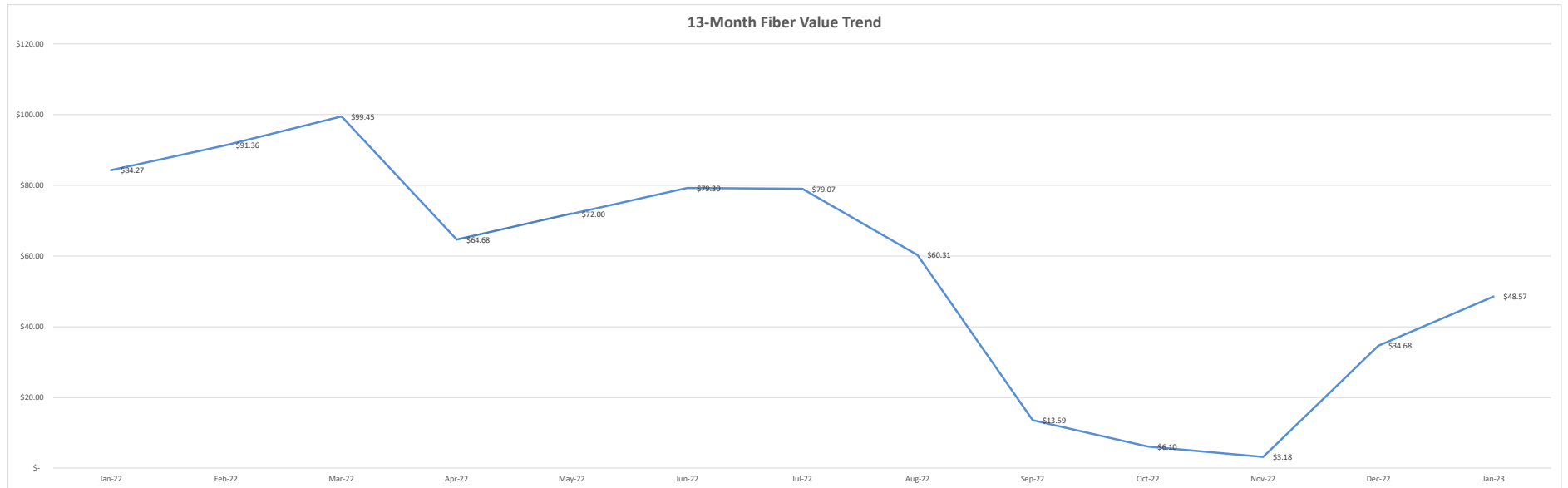
