Commodity Market Update

Scrap values for OCC cardboard has jumped this month, with MP mix paper increasing slightly. The heavy rainfall over the past few months has reduced the amount of dry recovered fiber available on the US west coast, and as a result paper and paperboard mills in Asia are looking for more tons. This has had a positive impact on pricing in February, but is not an indication of higher prices next month.

Scrap values for plastic, aluminum, glass, and metals remain stable.

Complications continue at the port of Oakland. The ILWU-PMA labor negotiations have still not been resolved, and a quick resolution is unlikely. Nevertheless the port continues to operate each day with inbound and outbound cargo flowing.

Export vessel frequency at Oakland is sufficient to continue with regular shipments, and no bales are being stored outside.

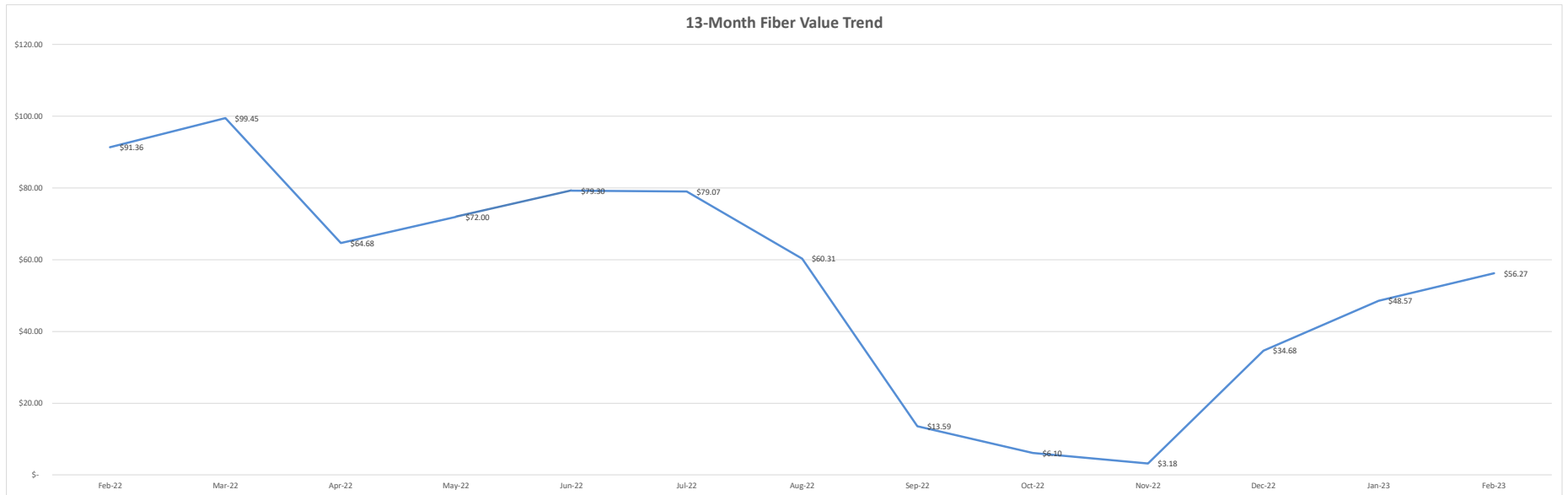
