Commodity Market Update

Scrap values for OCC cardboard dropped this month, with MP mix paper static. The general market trend for OCC and MP remains soft.

Scrap values for plastic, aluminum, glass, and metals remain stable.

The ILWU-PMA labor negotiations have still not been resolved, and some disruptions are being felt at west coast ports. At this time the port of Oakland continues to operate with only minor impacts.

Export vessel frequency at Oakland is below what we would like, but no recovered fiber bales are being stored outside.

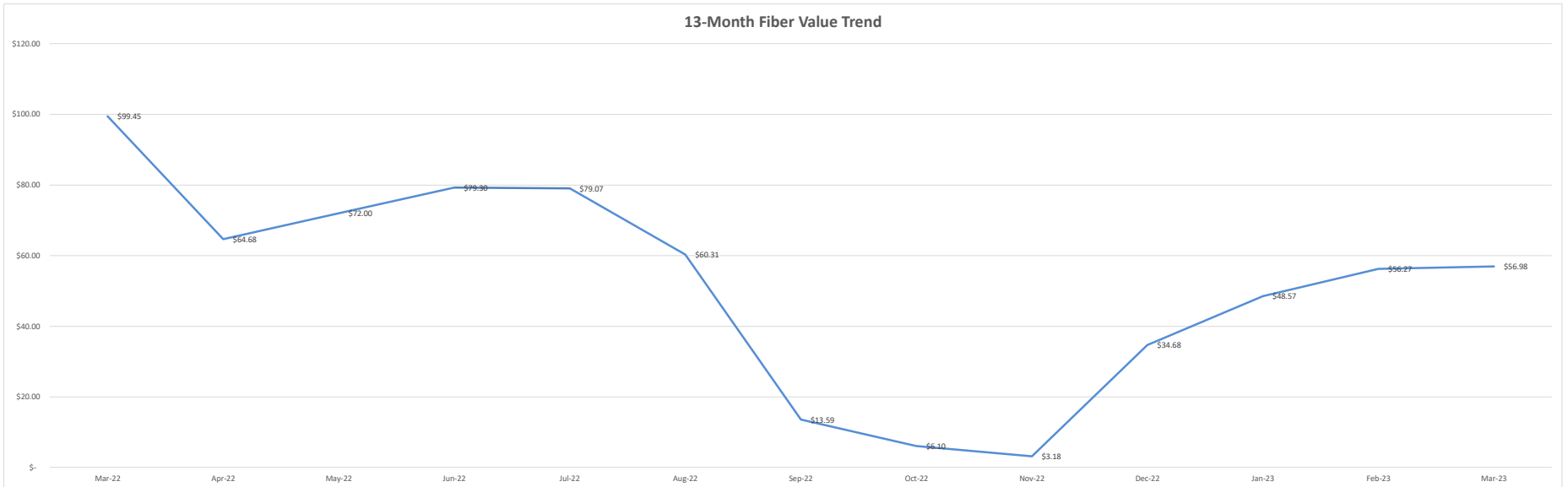
