Commodity Market Update

Scrap values for OCC cardboard (OCC) and Mix Paper (MP) are soft and well below historical averages. The general market trend for OCC and MP remains stagnant. Overall the demand for packaging materials (cardboard and duplex board, which are the primary products made from OCC and MP) is weak.

Scrap values for plastic, aluminum, and metals remain weak. Glass pricing is stable.

For export movement from the Port of Oakland, the ILWU-PMA labor negotiations have still not been resolved, and intermittent disruptions have impacted cargo flow to and from the port. At this time the port of Oakland continues to operate with only minor day-to-day impacts, and as a result no recovered fiber bales are being stored outside at the Shoreway facility.

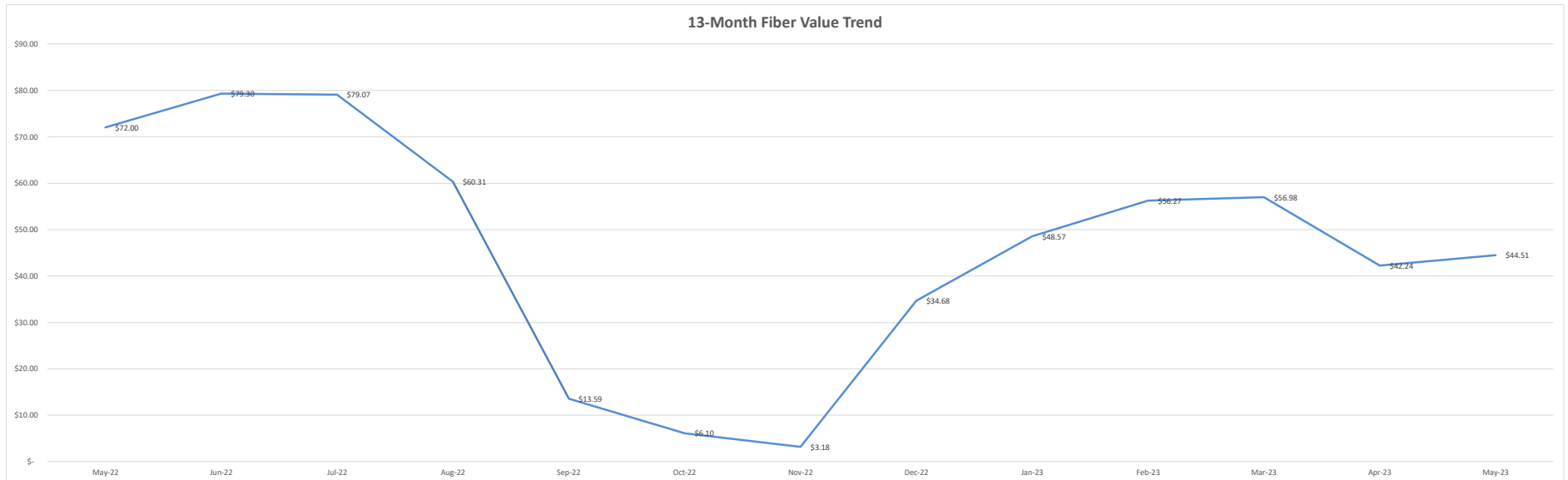
