Scrap values for OCC cardboard (OCC) and Mix Paper (MP) are soft are beginning to improve. Overall the global supply of recovered paper on the market is declining, and this is pushing prices up slightly.

Scrap values for plastic, aluminum, glass, and metals remain stable.

The port of Oakland continues to operate with only minor day-to-day impacts, and as a result no recovered fiber bales are being stored outside at the Shoreway facility.

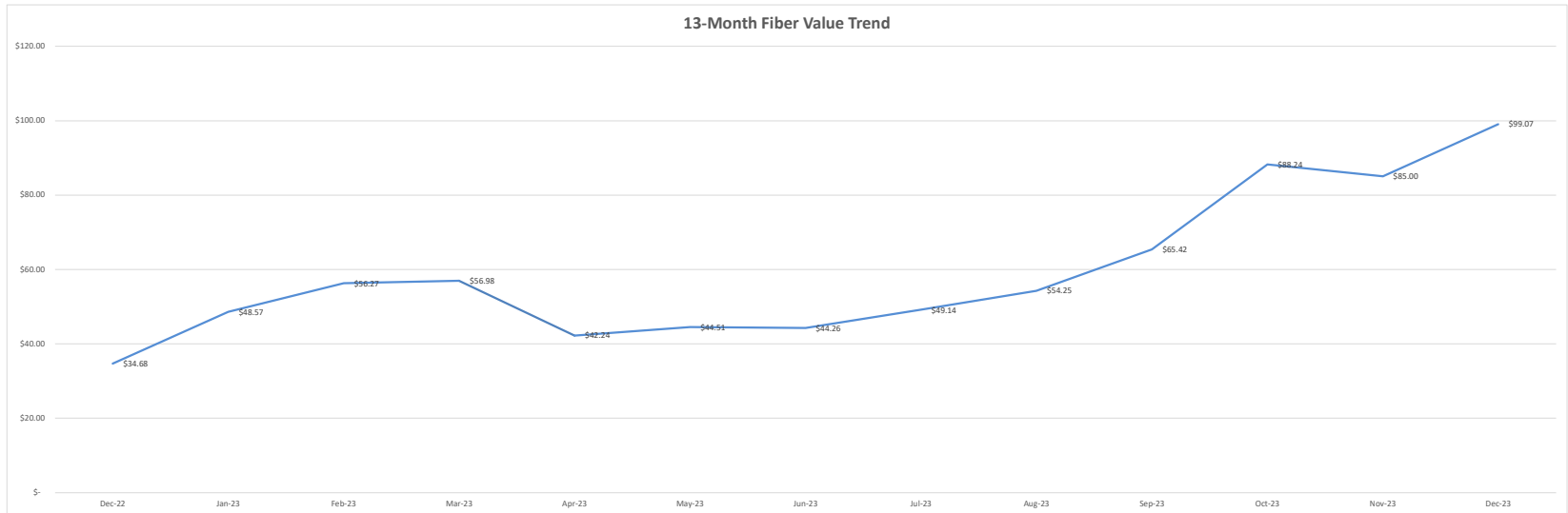
