I. SUMMARY ASSESSMENT

SIGNIFICANT ACCOMPLISHMENTS

Social Media Launch

Since the launch of the Recology San Mateo County (RSMC) Facebook account, we have received over 400 "likes" and have utilized social media to engage with a broader audience by sharing topics that include industry related news, collection schedules and "Beyond the Cart" services offered by RSMC. In addition to customer related services, RSMC promoted topics of community involvement and creative reuse projects. RSMC posts in Q1 2014 included the following:

- Holiday TreeCycling information
- Service day reminder for Martin Luther King Day and Presidents Day
- Bulky Item Collection information
- The CartSMART video
- Reminder to close container lids during the rainy season
- Local events, such as the Lunar New Year's Parade

Bare Necessities Toiletries Drive

In March, RSMC held a Bare Necessities drive. Toiletries were collected at the RSMC office from customers, employees, families, and friends to be donated to Community Overcoming Relations Abuse (CORA). CORA is the only agency in San Mateo County with the sole purpose of serving victims and survivors of domestic violence and abuse. CORA provides safety, support, and healing for individuals who experience abuse in an intimate relationship, and educates the community to break the cycle of domestic violence.




RSMC collected over 450 items. Such as, diapers, toothpaste, toothbrushes, shampoo, conditioner, soap and other items that can be utilized to maintain proper hygiene.

Customer Service Quality Assurance Surveys

Quality Assurance Surveys began in July 2013. Customer Service Representatives contact customers from the previous service day to survey them on their experience with the Call Center. Customers have the option of taking the survey over the phone or accessing the survey from a website provided to them. Of the 627 calls placed to customers, 105 surveys were completed. Any surveys with unanswered questions were eliminated from the results.

The results of the surveys were very positive with 99.3% of the customers giving a satisfactory rating, and less than 1% providing an unsatisfactory rating. Reasons cited for the satisfactory rating included friendliness, listening carefully, patience and responsiveness. 105 surveys were taken out of the 627 calls made to customers. Below is a breakdown of the survey results:



SIGNIFICANT CHALLENGES

Union Negotiations

The ratification of the third and final contract brings 6 months of negotiations to a close. Throughout this process, our employees continued to deliver the high quality of service our customers have come to expect over the past 3 plus years. Throughout this process, our goal, our promise, our commitment to the residents and businesses in the SBWMA service area was that any interruption in service due to a labor dispute as a result of our labor negotiations was simply not an option. It wasn't easy but we held to our promise. It is said that in any successful negotiation, concessions are made by both parties so to that end, these were successful negotiations. Our Recology negotiating team, Mr. Robert Morales from Teamsters Local 350, and all of our employee representatives worked tirelessly to come up with a workable agreement that will ensure uninterrupted collection services over the next five years.

On January 16, 2014, Angela Goebel, Mia Rossi, Misty McKinney, Sandra Tinoco, and Yvette Madera participated in the Webinar: Building Collection Infrastructure for Composting: Success in the Greater Worcester, MA. The webinar featured the project team that initiated the collection infrastructure to bring commercial hauling of source separated organics to a composting facility in the Worcester, Massachusetts area. The U.S. Environmental Protection Agency and the Massachusetts Department of Environmental Protection have been partnering to promote food waste diversion to composting along with Center for EcoTechnology (CET) who has been assisting Big Y Supermarkets with their recycling and composting programs in Massachusetts and Connecticut since the mid-1990's.

On February 12, 2014, Angela Goebel, Mia Rossi, Misty McKinney and Sandra Tinoco attended the Countywide Recycling Meeting. The meeting focused on the topic of beverage containers, California Redemption Value (CRV) and the RecycleWorks Volunteer Academy. Presenters discussed how beverage companies are increasing recycling and other sustainable practices, the processing of CRV containers at Shoreway Environmental Center, the many NexCycle locations in California and how they process the CRV containers. Another discussion included where glass cullet is formed for subsequent use by glass bottle makers and fiberglass manufacturers. The meeting concluded with an update to the recent changes to what materials are accepted for a refund and the future of the City and County Payment Program Grants.

On March 18, 2014, Angela Goebel, Mia Rossi, Misty McKinney, and Yvette Madera attended the Northern California Recycling Association (NCRA) Update. NCRA brought together waste industry professionals to learn about what's new in discarded materials management. They had more than 300 of the best and brightest from our industry all in one auditorium on one day. the NCRA update provides an opportunity for people to

network, catch up with friends, and get the latest information about industry technologies, policies, and innovations relating to the 4Rs (Reduce, Reuse, Recycle, and Rot (Compost).

A DESCRIPTION OF THE STRATEGY AND OVERALL APPROACH TO ATTRACT AND RETAIN A HIGH QUALITY AND EFFECTIVE COMMERCIAL RECYCLING PROMOTION PROGRAM AND SUPERVISORY STAFF

Recology is recognized in the industry for its environmental commitments, programs and services. We utilize our well-established networks to recruit the best-suited members for our diversion teams by posting on specific "green industry" LISTSERVs that target individuals in the field of waste reduction. We support growth and leadership development amongst our employees and encourage educational opportunities both internally and externally.

At Recology, we believe an employee's compensation includes more than just their paychecks; we recognize that providing a comprehensive benefits package is an important aspect of our employees' total compensation. By providing a competitive benefits package that includes Recology's Employee Stock Ownership Plan (ESOP), Recology is able to attract and retain highly qualified employees.

A DESCRIPTION AND STATUS OF MEETING THE GOALS AND OBJECTIVES FOR THE COMMERCIAL RECYCLING PROMOTION TEAM AND HOW THESE GOALS AND OBJECTIVES ARE TIED TO THE COMPENSATION INCENTIVE PLAN.

Our goals are to continue to recruit new recycling and compost customers and enhance the existing diversion programs in order to increase the volume of recyclable and compostable materials collected and delivered to the Shoreway Environmental Center. The following is an update on the goals and objectives achieved in Q1 2014.

†Site Checks are visual on-site collection container assessments for all commercial generators. Per Franchise Agreement Section 7.04, RSMC is required to conduct Site Checks at least once every three years for all commercial accounts.

^{*}Site Assessments are waste audits that are performed for the Top MSW Generators in each Member Agency. Per Franchise Agreement Section 7.04, RSMC is required to conduct these Site Assessments annually.

Quarter 2 (Q2) 2014 Goals

RSMC's goal is to continue to increase diversion by implementing new recycling and compost programs, and work directly with customers to maximize their existing programs. RSMC will continue to perform Site Assessments, conduct Site Checks to verify service levels and program efficiencies and provide technical assistance to customers on a requested or as needed basis.

With that in mind, the following goals have been set for the CRPT:

- Increase commercial recycling and compost service level volumes
- o Increase the commercial and/or MFD recycling and compost customer base
- o Decrease commercial and/or MFD solid waste disposal
- o Perform Site Assessments of Targeted MSW Generators
- o Conduct Site Checks for bin verification of on-site collection containers at MFD and/or Commercial accounts

The Q2 2014 goals for the CRPT will be achieved through the metrics outlined below:

- o Perform 150 Site Assessments of Commercial and/or MFD accounts
- o Conduct a minimum of 350 Site Checks of Commercial and/or MFD accounts
- o Recruit or increase a minimum of 100 recycling and/or compost accounts
- Target a minimum of 50 MFD and/or Commercial customers with a 20% or less diversion rate

Compensation Incentive Plan

The CRPT does not have a compensation incentive plan for achieving set goals. However, Recology management conducts annual performance reviews to verify achievement of goals, as well as evaluate an employee's level of Recology's Leadership Competencies, which include items such as strategic thinking, business acumen, communications and customer relations. The annual performance review is then used to determine potential merit increases.

A DESCRIPTION OF CONTRACTOR'S SALES STRATEGY FOR MAINTAINING AND/OR EXPANDING THE EXISTING COMMERCIAL RECYCLING ACCOUNT BASE AND DIVERSION LEVELS

To support our goal of increasing diversion and minimizing contamination, our strategy will be to focus attention on large accounts, to ensure their needs are being met and that maximum diversion is being achieved. The CRPT will also continue to utilize AB341 outreach and Contamination Site Checks to identify the needs of customers and areas in

which we can improve existing diversion programs or implement new ones. An outline of these strategies is noted below:

Target MFD/Commercial Customers with Low Diversion

The CRPT contacted 65 MFD customers during Q1 2014 with a 20% or below diversion rate. During on-site visits and/or Site Assessments, the CRPT was able to determine opportunities to reduce waste and assist the customers with increasing diversion levels. The CRPT established communication with these customers to offer cost savings analyses, on-site technical assistance and/or provide customized educational pieces that best fit their needs. In Q2 2014, the CRPT will continue to target MFD/Commercial customers with a diversion rate of 20% or less.

Maintenance of High Traffic Commercial Business Districts

The CRPT will continue to target high traffic corridors, such as strip malls or business districts, for a door-to-door education campaign. The CRPT will have direct communication with customers and provide tailored educational pieces regarding contamination, service level recommendations and other service needs.

Presentations

The CRPT can increase diversion and reduce contamination through outreach and education by conducting presentations. Presenting our programs to businesses and sharing the bigger vision of zero waste are excellent opportunities to connect with customers faceto-face. The CRPT presents at a range of venues ranging from corporate brown bag lunches to HOA meetings. The CRPT also educates through interactive activities at presentations, such as "The Sorting Game", where participants are provided with a bag of items that they sort into 3-color coded containers. These avenues also provide the CRPT an opportunity to answer specific recycling and composting questions posed by attendees, which helps customers to become engaged and more vested in the recycling and composting programs.

A DESCRIPTION OF THE SERVICES PROVIDED TO THE COMMERCIAL AND AGENCY FACILITY SECTORS.

Services provided by RSMC to our Commercial and Agency Facility sectors include Single-Stream Recycling, Compost and Solid Waste Material collection. Support services provided include conducting Site Assessments and Site Checks, determining adequate and most cost effective service levels, providing presentations and trainings, and distributing public education materials and internal containers.
