Shoreway Facility Operations Monthly Reporting  
January 2019**

Dear Joe:

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain weak. Fortunately, the California CRV program is financially solvent, and payments from the State for Refund, Processing, and Administration will continue to sustain non-fiber revenue contributions. Scrap pricing for fiber (cardboard and paper) remains weak and unstable. End users consuming recovered fiber continue to demand higher quality dry material. The global market for mix paper is in oversupply, and that pricing remains weak. So far 2019 is off to a wet start with respect to rainfall, and excess moisture (common in the industry, even though carts have lids) negatively impacts MRF throughput, increases contamination levels in sorted products, and reduces the market value for paper and cardboard. When moisture levels of sorted products exceed 20% then the risks of moisture claims and the severity of them increases.

Cardboard and Mix Paper pricing remained flat month over month with material sales at \$97.00 per ton and \$11.00 per ton respectively. MRF 3 Mix Glass charge increased \$1.40 per ton from prior month, and Mix Rigid Plastic (MRP) improved \$19.08 per ton from prior month. Scrap Metal pricing dropped \$30.00 per ton from prior month to \$40.00 per ton.

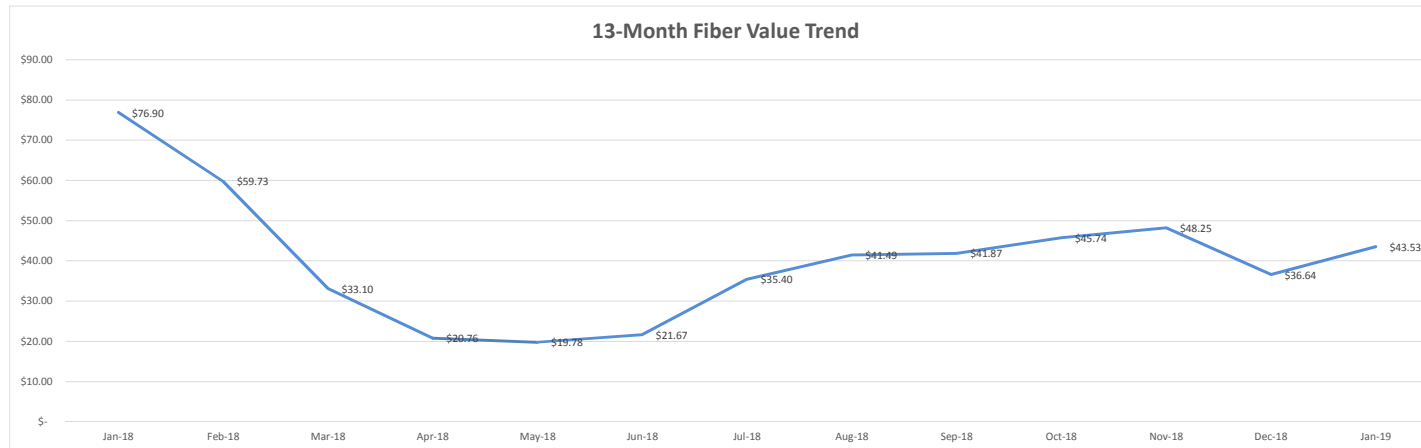
