Commodity Market Update

Scrap values for non-fiber (plastic, glass, aluminum, and metals) remain weak. Non-fiber pricing (scrap + CRV) improved slightly. Scrap pricing for fiber (cardboard and paper) remains depressed and unstable. Cardboard (OCC) dropped slightly and Mixed Paper was unchanged.

The ongoing trade war with China results in US origin recovered fiber (cardboard and paper) being higher cost than those from other countries. In addition, China continues to reduce the quantity of fiber allowed into the country by slashing import permits. The US domestic consumption of recovered fiber is steady, but mill inventories are high. Pricing for recovered fiber both domestically and export continues to slide. There remains a tremendous uncertainty regarding whether or not China will ban the import of all recyclables in 2020. If that were to happen then the impact on the recycling industry in North America would be catastrophic.

The trend continues for some of the light industry manufacturing capacity in China to move to other SE Asian countries. As this happens those countries need paper and paperboard for printing and packaging materials. For the most part those countries do not have sufficient pulp or domestic recovered fiber supply needed, and as such they are increasing their imports of US recovered paper. Several mill groups are installing and planning additional paper and paperboard machines in a few SE Asian countries, and as they come on line they will consume additional US recovered fiber. SBR continues to monitor domestic and export markets so that recovered fiber is marketed to whichever region is consuming it.

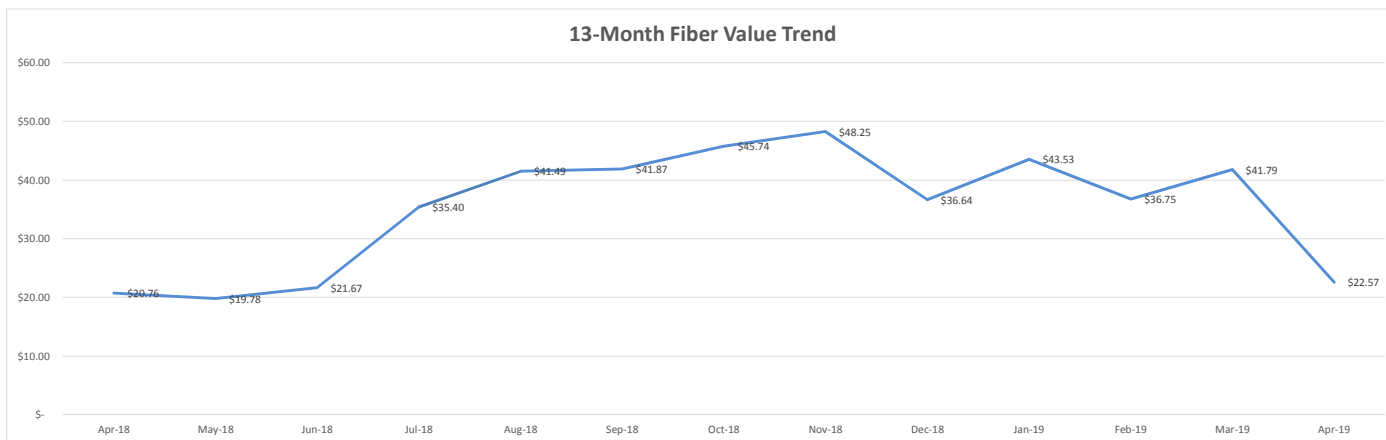
