Effective July 1, 2016, CalRecycle adjusted payments for California Refund Value. Supporting documentation has been provided.

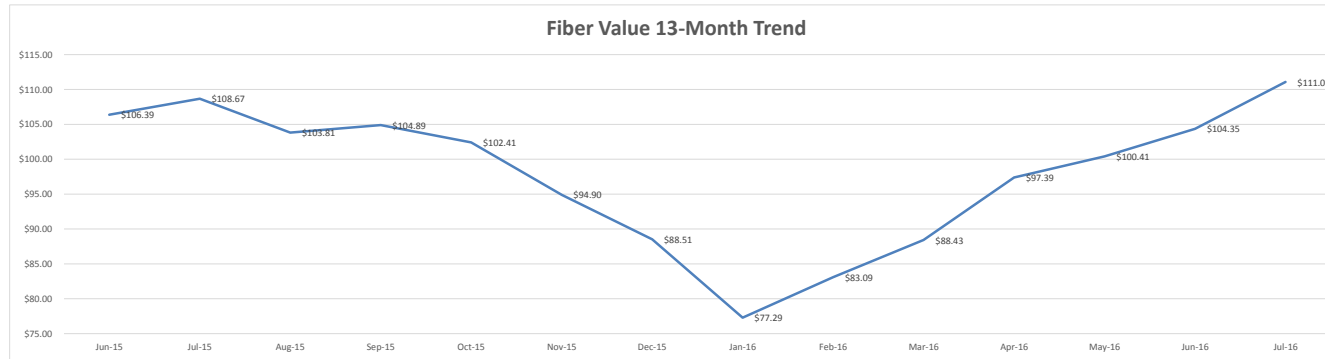
